### **GROSS DOMESTIC PRODUCT: FOURTH QUARTER 1999 (ADVANCE)**

Real gross domestic product -- the output of goods and services produced by labor and property located in the United States -- increased at an annual rate of 5.8 percent in the fourth quarter of 1999, according to advance estimates released by the Commerce Department's Bureau of Economic Analysis. In the third quarter, real GDP increased 5.7 percent.

The Bureau emphasized that the fourth-quarter "advance" estimates are based on source data that are incomplete or subject to further revision by the source agency (see the box on page 3). The fourth-quarter "preliminary" estimates, based on more comprehensive data, will be released on February 25, 2000.

The major contributors to the increase in real GDP in the fourth quarter were: Personal consumption expenditures (PCE) for goods and services, producers' durable equipment (PDE), and residential structures. The contributions of these components were partially offset by an increase in imports of goods and services, and decreases in government spending and in exports of goods and services.

The price index for gross domestic purchases, which measures prices paid by U.S. residents, increased 2.3 percent in the fourth quarter, compared with an increase of 1.7 percent in the third. Excluding food and energy prices, which are normally more volatile than many other prices, the price index increased \*.\* percent in the fourth quarter, compared with an increase of 1.7 percent in the third.

Real personal consumption expenditures increased 5.3 percent in the fourth quarter, compared with an increase of 4.9 percent in the third. Durable goods purchases increased 11.8 percent, compared with an increase of 7.7 percent. Nondurable goods increased 6.1 percent, compared with an increase of 3.6 percent. Services expenditures increased 3.5 percent, compared with an increase of 5.0 percent.

NOTE.--Quarterly estimates are expressed at seasonally adjusted annual rates, unless otherwise specified. Quarter-to-quarter dollar changes are differences between these published estimates. Percent changes are calculated from unrounded data and annualized. "Real" estimates are in chained (1996) dollars. Price indexes are chain-type measures.

Real nonresidential fixed investment increased 2.5 percent in the fourth quarter, compared with an increase of 10.9 percent in the third. Nonresidential structures decreased 5.3 percent, compared with a decrease of 3.8 percent. Equipment and software increased 4.9 percent, compared with an increase of 15.7 percent. Real residential fixed investment decreased 1.2 percent, compared with a decrease of 3.8 percent.

Real exports of goods and services increased 6.9 percent in the fourth quarter, compared with an increase of 11.5 percent in the third. Real imports of goods and services increased 10.6 percent, compared with an increase of 14.9 percent.

Real federal government consumption expenditures and gross investment increased 16.0 percent in the fourth quarter, compared with an increase of 4.1 percent in the third. National defense increased 18.9 percent, compared with an increase of 11.2 percent. Nondefense increased 11.0 percent, in contrast to a decrease of 7.1 percent. Real state and local government consumption expenditures and gross investment increased 4.4 percent, compared with an increase of 4.8 percent.

The real change in private inventories added percentage point to the fourth-quarter change in real GDP, after adding 1.09 percentage points to the third-quarter change. Businesses increased inventories \$65.4 billion in the fourth quarter, following increases of \$38.0 billion in the third quarter and \$14.0 billion in the second.

Real final sales of domestic product -- GDP less change in private inventories -- increased 4.6 percent in the fourth quarter, compared with an increase of 4.5 percent in the third.

### **Gross domestic purchases**

Real gross domestic purchases -- purchases by U.S. residents of goods and services wherever produced -- increased 6.3 percent in the fourth quarter, the same increase as in the third.

### **Disposition of personal income**

Current-dollar personal income increased \$139.2 billion in the fourth quarter, compared with an increase of \$98.8 billion in the third. Personal tax and nontax payments increased \$22.8 billion, compared with an increase of \$21.0 billion.

Disposable personal income increased \$116.4 billion in the fourth quarter, compared with an increase of \$77.8 billion in the third. Real disposable personal income increased 4.6 percent, compared with an increase of 2.9 percent.

Personal outlays increased \$125.1 billion in the fourth quarter, compared with an increase of \$106.3 billion in the third. Personal saving -- disposable personal income less personal outlays -- was \$130.8 billion in the fourth quarter, compared with \$139.5 billion in the third. The personal saving rate -- saving as a percentage of disposable personal income -- decreased from 2.1 percent in the third quarter to 1.9 percent in the fourth.

## **Current-dollar GDP**

Current-dollar GDP -- the market value of the nation's output of goods and services -- increased 7.9 percent, or \$179.3 billion, in the fourth quarter to a level of \$9,477.1 billion. In the third quarter, current-dollar GDP increased 6.8 percent, or \$151.6 billion.

Information on the assumptions used for unavailable source data is provided in a technical note that is posted with the news release on BEA's and STAT-USA's Web sites. Within a few days after the release, a detailed "Key Source Data and Assumptions" file is also posted on the STAT-USA site. ### Comparisons of Revisions to GDP

Quarterly estimates of GDP are released on the following schedule: “Advance” estimates, based on preliminary and incomplete source data and BEA assumptions about missing source data, are released near the end of the first month after the end of the quarter; as more detailed and more comprehensive data become available, “preliminary” and “final” estimates are released near the end of the second and third months, respectively. The “latest” estimates reflect the results of both annual and comprehensive revisions.

Annual revisions are usually carried out each summer and cover the quarters of the most recent calendar year and of the 2 preceding years. Comprehensive (or benchmark) revisions are carried out at about 5-year intervals and incorporate definitional and classificational changes that update the accounts to portray more accurately the evolving U.S. economy and statistical changes that update the accounts to reflect the introduction of new and improved methodologies and the incorporation of newly available and revised source data.

The table below shows comparisons of the revisions between quarterly percent changes of GDP for the different vintages of the estimates. These comparisons can be used to assess the likely size of future revisions. For example, two-thirds of the revisions between the quarterly change in the advance estimate of real GDP and that in the final estimate were within a range of -0.6 to +0.9 percentage point. Thus, based on past history, the fourth-quarter change in real GDP now estimated at 5.8 percent at an annual rate, is not likely to be revised below 5.2 percent or above 6.7 percent in the next two releases.

## Explanatory Note: Measures of Output and Prices

This note describes the calculation of chain-type quantity and price indexes used in the NIPA's.

Changes in current-dollar GDP measure changes in the market value of goods, services, and structures produced in the economy in a particular period. These changes can be decomposed into quantity and price components. Quantities, or "real" measures, and prices are expressed as index numbers with the reference year--at present, the year 1996--equal to 100.

The annual changes in quantities and prices are calculated using a Fisher formula that incorporates weights from two adjacent years. (Quarterly changes in quantities and prices are calculated using a Fisher formula that incorporates weights from two adjacent quarters; quarterly indexes are adjusted for consistency to the annual indexes before percent changes are calculated.) For example, the 1997-98 annual percent change in real GDP uses prices for 1997 and 1998 as weights, and the 1997-98 annual percent change in GDP prices uses quantities for 1997 and 1998 as weights. These annual changes are "chained" (multiplied) together to form time series of quantity and price indexes. The Fisher formula also produces percent changes in quantities and prices that are not affected by the choice of reference years. In addition, because the changes in quantities and prices calculated in this way are symmetric, in general, the product of a quantity index and the corresponding price index equals the current-dollar index. (BEA also publishes a measure of the price level known as the "implicit price deflator (IPD)," which is calculated as the ratio of current-dollar value to the corresponding chained-dollar value, multiplied by 100. The values of the IPD are very close to the values of the corresponding "chain-type" price index for all periods.)

Chain-type quantity and price indexes for GDP and its major components are presented in this release as index numbers in table 5 and in the form of percentage changes from the preceding period in tables 1, 4, 6A, and 6B. Contributions by major components to changes in real GDP are presented in table 2. BEA also prepares measures of real GDP and its components in a dollar-denominated form, designated " chained (1996) dollar estimates." For GDP and most other series, these estimates, which are presented in table 3, are computed by multiplying the 1996 current-dollar value by a corresponding quantity index number and then dividing by 100. For example, if a current-dollar GDP component equaled \$100 in 1996 and if real output for this component increased 10 percent in 1997, then the chained (1996) dollar value of this component in 1997 would be \$110 ( $\$100 \times 1.10$ ).

For analyses of changes over time in an aggregate or in a component, the percentage changes calculated from the chained-dollar estimates and from the chain-type quantity indexes are the same; any differences will be small and due to rounding. However, because the relative prices used as weights for any period other than the reference year differ from those used for the reference year, the chained-dollar values for the detailed GDP components will not necessarily sum to the chained-dollar estimate of GDP or to any intermediate aggregate. A measure of the extent of such differences is provided by a "residual" line, which indicates the difference between GDP (or another major aggregate) and the sum of the most detailed components in the table. For periods close to the reference year, when there usually has not been much change in the relative prices that are used as weights for the chain-type index, the residuals tend to be small, and the chained (1996) dollar estimates can be used to approximate the contributions to growth and to aggregate the detailed estimates. As one moves further from the reference year, the residual tends to become larger, and the chained-dollar estimates become less useful for analyses of contributions to growth. Thus, the contributions to percent change shown in table 2 provide a better measure of the composition of GDP growth. In particular, for components for which relative prices are changing rapidly, calculation of contributions using chained-dollar estimates may be misleading even just a few years from the reference year.
